Council Member Martin's Spring CIP Town Hall was held at Space Center Houston, Thursday, Feb 16th. Council Member Jack Morman led a District E Capital Improvement Projects (CIP) town hall meeting.

Representatives from Public Works and Engineering, spoke about upcoming infrastructure projects in the area

Representatives from Houston Parks and Recreation, spoke about Sylvan Rodriguez Park Master Plan Meeting and Council District Service Fund Projects in the area

Chief Resiliency Officer, Stephen Costello, provided a storm surge update.

HPD Clear Lake Substation Captain Stevens will be addressed the panhandling issue.

In summary: The presentations focused on projects in the southern part of our District E. District E stretches from Kingwood to Clear Lake. Meadowcreek Village is roughly in the middle.

Announcement made: The ribbon cutting of the pavilion, at Meadowcreek Village Park March 9th at 5:00 PM

In our surrounding area, they presented a major street renovation for Allen-Genoa Road from Highway 225 to Southmore Avenue along the Houston Port Authority dredging placement area on the East side and the Allendale town site, Forest Oaks subdivision and Oak Meadows subdivision on the West side. Allen-Genoa Road south of Southmore Avenue "all-the-way" to Genoa-Red Bluff Road is maintained by the City of Pasadena. CIP completion date for this effort is scheduled for the Fall 2017.

Solid Waste Management

"Tree Waste" is defined as "clean" wood waste such as tree limbs, branches, and stumps. Lumber, furniture, and treated wood will **NOT** be accepted.

Junk Waste may **NOT** be placed for collection during a Tree Waste month.

Tree Waste months are **January, March, May, July, September, and November.**

"Junk Waste" is defined as items such as furniture, appliances, and other bulky material. Tree Waste is accepted during Junk Waste Months; however, to ensure your Tree Waste is recycled, you may hold your tree waste materials until the next Tree Waste designated month or take it to a neighborhood Depository/Recycling Center.

Junk Waste months are **February, April, June, August, October and December.**

Tires

Residents may place up to **4 tires** at the curb for collection **during Junk Waste months.** Collection crews will separate the tires from the Junk Waste. It may take up to a week before crews return and retrieve the tires. Separating the tires from the rest of the Junk Waste allows the SWMD to properly process tires.
